- b) The institution shall pay salary to the teaching staff as prescribed by concerned State Govt.
 - c) The institution shall obtain affiliation from the examining body before the commencement of the course.
 - In the institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Eastern Regional Committee.
 - e) The Reserve Fund for an amount of Rs. 3.00 lakh be maintained in the form of FDR in favour of the management/institution.
 - .f) The institution shall maintain and update their website as per NCTE regulations.
 - g) The intake, eligibility and admission procedure shall be strictly adhered as per NCTE norms.
